HEMP PLASTIC MATERIALS

Hemp fiber is an excellent alternative to cotton for clothes and furniture and can also be called an eco-fabric. A high amount of pesticides is used when growing cotton and hemp plants do not need pesticides at all and is a carbon negative plant.



HEMP CLOTHING

Cellulose is the ingredient needed to make paper, and trees only produce 30 percent of it. Converting trees into cellulose wastes tons of energy and resources. **Hemp fiber, however, produces 83 percent cellulose**. In addition, hemp breathes in 4x the carbon dioxide (CO2) of trees during its extremely short 12-14 week growing cycle.

HOW TO PROFIT From Your Hemp Business Ideas



A

An independent agent enters into an agreement to sell someone's product but cannot use the manufacturer's trade name as part of its trade name. **A distributor may sell to a number of dealers**. A dealer then typically sells only to a consumer or retailer.



DISTRIBUTORSHIP OR DEALERSHIP



This involves selling another company's products through a distribution system of racks in stores that the rack jobber services. The buyer typically **enters into an agreement with the parent company** to market their products to stores through store racks.

RACK JOBBER OR RACK MERCHANDISER

The licensee has the right to use the seller's **trade name and the methods, using equipment, technology, and product**. Using the trade name is optional to the licensee.
